# 108/18 Streetlights - to discuss findings and actions from Balfour Beatty's audit

Cllr GC reported that Balfour Beatty has carried out an inspection and electrical testing on all 38 lights in Westbury. Findings include:

- Broken bracket and loose lantern on two lights in Mill Lane
- Eight lights need earthing

- · Eight poles showing signs of rust
- One metal pole bent
- Five lights don't have isolators

None of the works have been deemed to be high risk. Cllr GC has asked for a price and will prioritise findings. He advised that for some repairs, the electricity would have to be switched off so he would ask for as many repairs to be carried out during that time as possible to save money.

CK advised that Balfour Beatty are unable to supply us with an emergency callout number. GC agreed to chase.

#### 109/18 To discuss the possibility of having a Salvation Army clothing bank at the village hall

A letter had been received asking if we would like to site a clothing bank at the village hall advising that the Salvation Army would pay a reasonable percentage of the average midrange material recycling world price (currently 50% of this price is £275.00 per tonne) and the Salvation Army would retain the remaining amount to fund the fantastic work they do in the community. Councillors agreed they would be happy to house the bin but as WVHA lease the hall, it would need their agreement. CK will contact the Chair of WVHA.

# 110/18 To receive an update on Oxfordshire's footpaths

Cllr VW reported that Alex Humphreys, Countryside & Highway Records Officer at Oxfordshire County Council (OCC) has finalised her report. She said there has been a delay because it is a particularly complex case. The report and all the evidence has now been sent to their lawyers. They will then be in a position to issue the determination notice which she hopes will be within the next two to three months.

VW said we should write to OCC and copy in the Secretary of State and the Rt. Hon. John Bercow MP, reminding them that the planning inspectorate deadline to determine applications should have been 30th June this year, not in six months' time.

#### 111/18 To discuss arrangements for Christmas 2018

CK advised that she and Cllr SB had met to discuss arrangements. The date of Friday 7<sup>th</sup> December has been agreed for the big switch on, Christmas carols and a Christmas Market – a free event, all to take place at the village hall from 6.30 pm. Westbury Community Shop will also be open selling Christmas ware and offering mince pies and hot drinks etc.

Derek Crane has very kindly offered to donate a Christmas tree which councillors unanimously approved and thanked him for. We will arrange for a hole to be dug to the front of the hall (by Richard Haynes) and a metal tube will be inserted that can be used annually for this purpose in early November.

#### 112/18 Reports

- a. Play Park JS advised that he and CK had met with Kompan contractors to talk through the installation and update of the equipment. The work will commence on 1<sup>st</sup> October and it is hoped the park will be open in time for the half term holiday. One piece of equipment the net twister will be installed slightly later as we have asked for the 2018 edition. The fence will be installed towards the end of October/beginning of November. - **b. Highways** A request for a new grit bin has been received to be located on the bend outside the Church. Cllr GC will contact Dave at Bucks Highways to ask if this is a possibility.
- **c. Utilities** Cllr GC advised that five faulty lights have recently been reported to Balfour Beatty for repair on Fulwell Road, Orchard Place and Main Street.
- d. Village Hall & WVHA Cllr VW reported that she had attended the committee meeting on Monday; the Westival weekend was a great success and made a good profit with discussions already underway to make it bigger and better next year. Bookings are good and future events planned include Race Night on 13<sup>th</sup> October, a possible Halloween trail, a village breakfast on 4<sup>th</sup> November (date changed from 7<sup>th</sup> October) and the Christmas Market on 7<sup>th</sup> December.
- **e. Community Shop & Café** Cllr VW advised that the committee had been in contact with HS2 to discuss the possibility of utilising the hall's facilities when work commences next year.
- **f. Footpaths** Nothing to report at this time.
- **g. HS2** CK reported that she had been in contact with all groups and organisations in Westbury regarding CEF funding. She is in the process of putting together a wish list and hopes to have a proposal ready for the next meeting.

It was hoped for this to have been implemented this Spring, but unfortunately due to personal circumstances it was postponed. Chair JS and CK recently met with Derek to discuss the type of tree species to be planted etc and works will commence this coming Spring. Derek will ask Richard Haynes to prepare the ground and once the tree and bench are in place, the parish council will take over the responsibility and insurance.

Chairman JS asked for the Parish Plan to be put on the next agenda for discussion. CK suggested funding for the plan should be included in the HS2 wish list.

Chairman JS asked Cllr GC to request Bucks Highways fill all grit bins before the winter. Action: GC

Chairman JS asked if we are planting bulbs around the village this year. Councillors agreed it would be a nice idea for more flowers as they looked so pretty last Spring. A budget will be agreed out of council.
