<b>WCS</b> - JS advised that as stated in 1.1 of the lease "annual rent will be free for the first 2 years and then subject to a minimum of £1000 and maximum of £3000 (subject to various conditions)." 99/18 Items relating to WCS	
A report (addendum 1) and year two accounts (addendum 2) were circulated. SL & JH advised that year 2 has been a year of fluctuating performance. The projection for year 3 will be available at the next meeting in April when there will be a clearer idea of how well the new staffing system has worked.  No new grants have been applied for. However, WCS will put together an application to apply for HS2 Community Environment Funding which can be included with other village applications. A date of 1 <sup>st</sup> April was agreed to have the application ready by.	wcs
