

Notice of temporary road closure, A422

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

As part of our continued preparatory works, the A422 will be closed overnight for approximately 1 week. These works are required for the excavation of a utilities trench across the road. The work is needed to provide a new water connection to our A422 south compound.

As the preparatory works will require large plant and machinery, we are required to close this section of road. This is for the safety of road users and our staff. To reduce the inconvenience to road users, this closure will be in place overnight.

Access to properties will be maintained at all times and emergency responders will have access through.

When will these works take place?

The A422 will be closed overnight, 7.00pm to 6.00am, from Monday 11 October to Sunday 17 October, with a diversion in place. We will work to reopen the roads to reduce disruption as soon as possible.

Should there be delays to our works, contingency dates for the closure of the A422 will be 7.00pm to 6.00am, from Monday 18 October to Saturday 30 October.

Overnight road closures and some additional traffic.

Noise from plant and equipment used for the works.

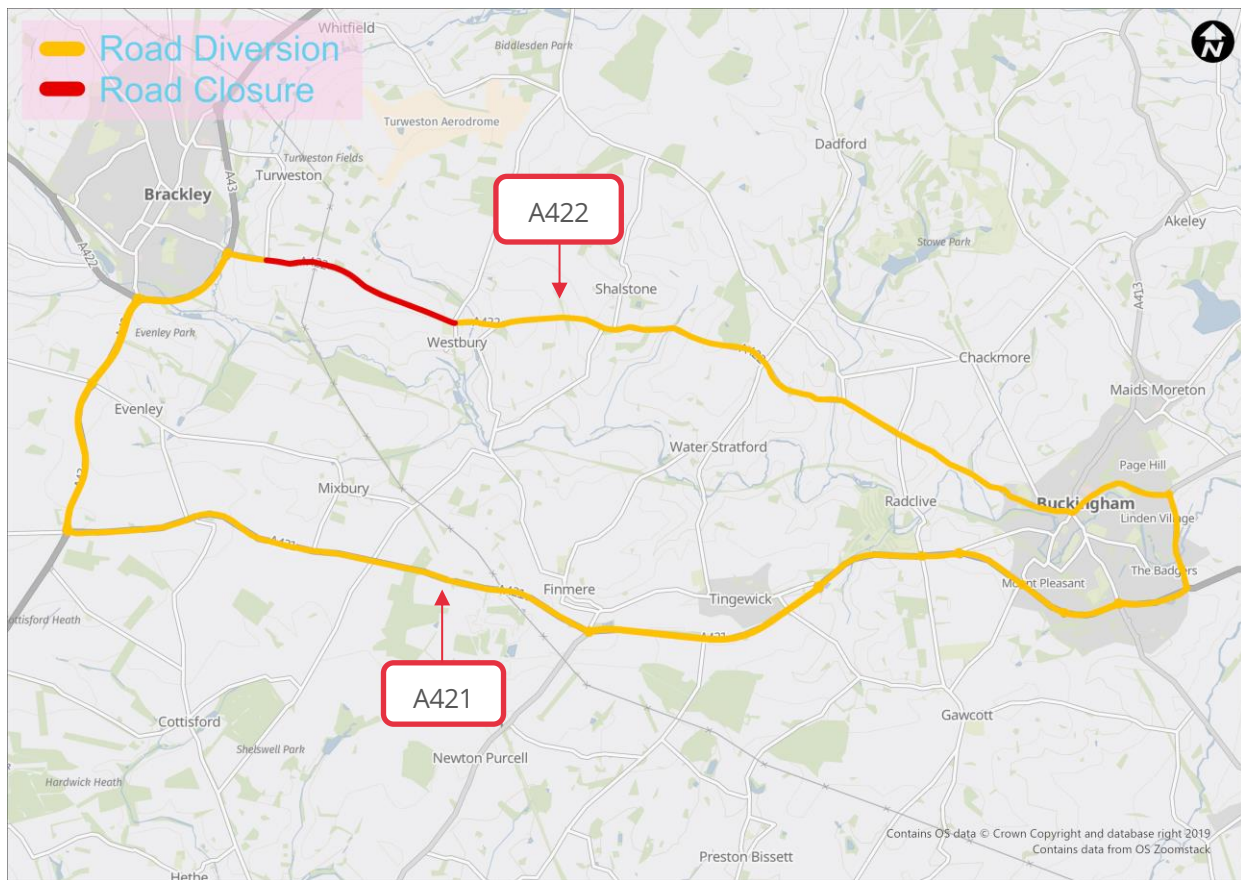

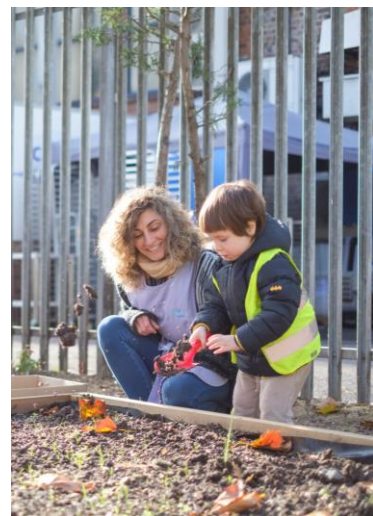
About our Community and Business Funds
