



Notice of temporary road closure, A4421

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

To complete some finishing works at the Finmere Bridge it will be necessary to close the A4421 overnight, for approximately 1 week. These works will involve the completion of the bridge hoarding. Once these works are complete, the A4421 will reopen as normal.

Due to these finishing works requiring large plant and machinery, we are required to close these sections of road until they are complete. This is for the safety of road users and our staff. To reduce the inconvenience to road users, this closure will take place overnight.

When will these works take place?

The A4421 will be closed overnight, 8.00pm to 6.00am, from Monday 27 September to Friday 1 October, with a diversion in place. It will also be closed, 9.00pm to 6.00am, from Friday 1 October to Monday 4 October, with a diversion in place.

Should these works be delayed, the contingency dates for the closure are Monday 4 October to Friday 8 October, 8.00pm to 6.00am, with a diversion in place. It will also be closed from Friday 8 October to Saturday 11 October, 9.00pm to 6.00am, with a diversion in place.

We will work to open the roads to reduce disruption as soon as possible.

Works will commence Monday 27 September 2021

Normal working hours:

Monday to Friday

8.00am – 6.00pm

Saturdays

8.00am – 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

Varied activities with both quiet and busier periods.

Road closures and some additional traffic.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

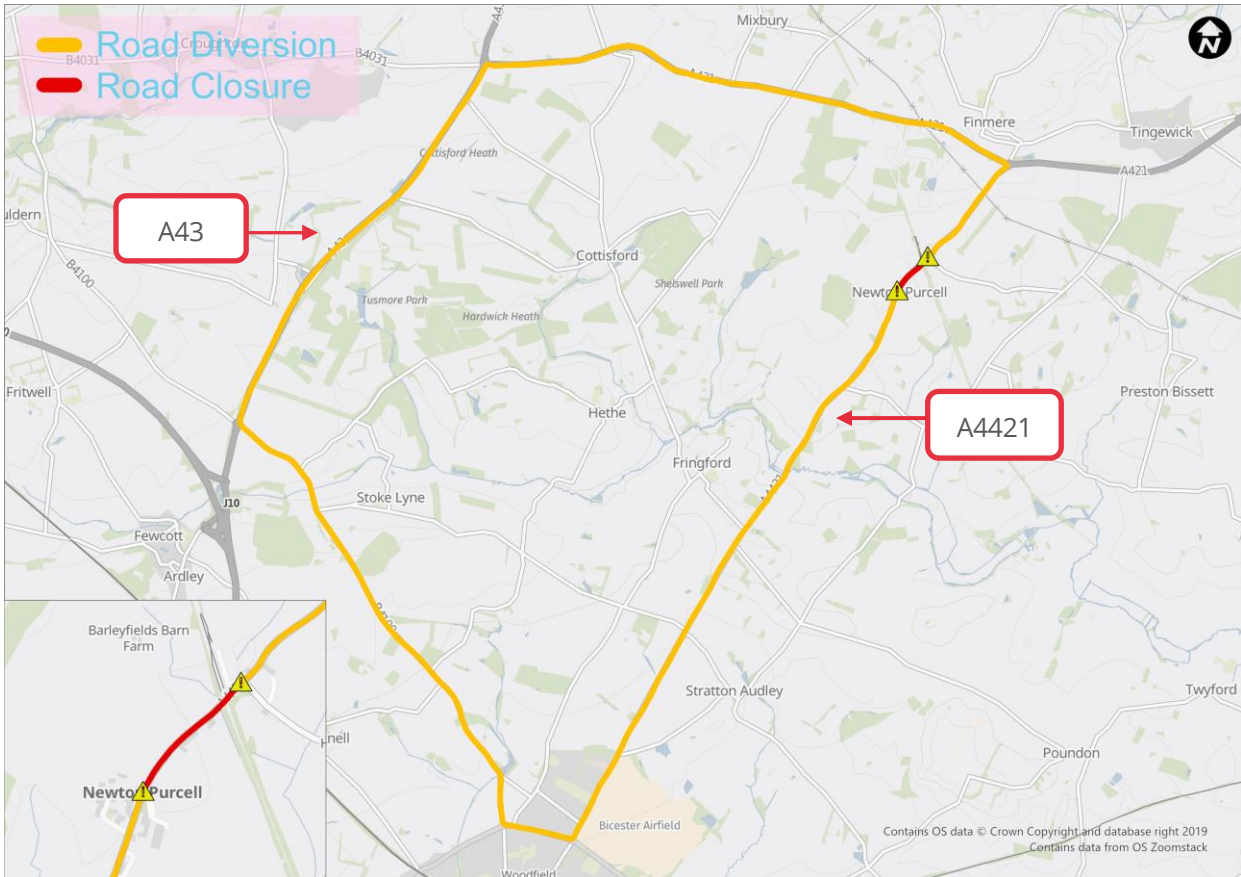

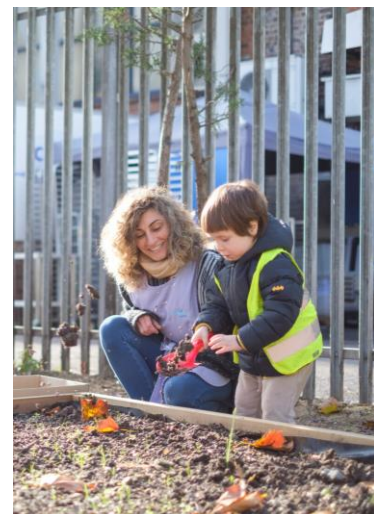
About our Community and Business Funds
